Assessment Tasks

Students must demonstrate the following tasks:

- 1. Practical Assessment
- 2. Knowledge Assessment (verbal or written)

Results C = Competent or NC = Not Yet Competent

- Student has three (3) attempts
- Student must sign Result Sheet at end of course
- If student is unhappy with result a written appeal must be sent to Train Safe NT within thirty (30) days (Student Appeals Result Policy 14)

Student: Initially you will be asked to acknowledge that you have received the necessary training and practice to undertake assessment. This assessment tool is designed to assist you and your assessor to determine competence in the unit of competency.

Context: The tasks are designed to permit you to demonstrate your skill at recovering a bogged vehicle this includes using an electric winch, hand winch, exhaust jack or reducing tire pressure. The vehicles maybe bogged in sand, mud, loose terrain. The assessment involves application of skills and knowledge required in workplace.

You will then be asked to undertake a practical and verbal assessment. To demonstrate your ability to perform the tasks of the unit of competency to the standard required by the FWP Training Package.

The practical assessment tasks must be completed a minimum of two (2) times over period of the course.

Before assessment you should:

- Tell the assessor that you are ready for assessment
- Be advised by the assessor when and how the assessment will take place (including reference to this assessment tool)
- Be advised of any special preparation, materials or equipment that will be needed for undertaking the assessment
- Advise the assessor of any special needs that you may have (eg assistance with language)

During your performance of assessment tasks you will be expected:

- To demonstrate your competency without assessor assistance (except for assistance with indirect matters, such as writing answers on your behalf)
- To stop all activity immediately, if directed by your assessor
- Your assessor may also ask questions to gain more information on the way you are performing the tasks.

Following assessment you will be provided with:

- Feedback on the outcomes of your assessment
- Information on opportunity for further training and/or re-assessment if you have been unsuccessful
- Information on the student appeals process

Task 3	The student used the snatch block to recovered a vehicle bogged.
Task 4	The student used the hand winch to recovered a vehicle bogged.
Task 5	The student informed all bystanders of the hazards and organized them to move away.
Task 6	The student communicated with workers or other persons involved in recovering the vehicle.
Task 7	The student used personal protective equipment (PPE)
Task 8	The student inspected all recovery equipment for damaged or worn parts.
Task 9	The student identified the Working Capacity of the hand winch.
Task 10	The student identified the GVM of bogged vehicle and
	calculated the suitable Bow shackle WLL and Winch rating (kg) and Tree saver capacity (kg).
Task 11	The student operated the electric winch and returned the cable.
Task 12	The student reduced the tire pressure and recovered a bogged vehicle.
Task 13	The student used the jack to raise vehicle.
Task 14	The student washed the vehicle and equipment at the end of the course.
